

FOOD VENDOR AGREEMENT FOR
BOSHEARS SKYFEST 2008

FEES: Fees for the exhibitor will be figured by the Vending Director according to the size of space required. Fees for food vendors for a 20x25 front line space is \$450.00

Contracts accompanied by a 50% non-refundable deposit will secure a space. Deposits are due by Friday, October 3, 2008. Those vendors requiring additional space will negotiate directly with Vending Director, Doug Rhodes, at telephone # (706) 833-1233.

RULES:

- * The Exhibitor/Vendor must furnish all tables, tents and other equipment required at the show.
- * Electricity is available upon request; the Exhibitor/Vendor must furnish all extension cords and other electrical needs.
- * The Vending Director will assign vendor parking
- * Exhibitors/Vendors are responsible for any taxes, permits, insurance and valuables.
- * Vendor setup must be completed by Friday, October 17th, at 6 p.m.
VENDING COORDINATOR, DOUG RHODES, WILL NOT PERMIT VENDOR TAKE DOWN UNTIL APPROVED. (For safety reasons)
- * Boshears Memorial Fly-In, Inc exclusively retains the official logo of Boshears Skyfest 2008. Any unauthorized use of this logo is expressly forbidden and will be pursued legally.
- * Boshears Skyfest 2008 will be the exclusive supplier of non-alcoholic beverages for the airshow. Those vendors wishing to sell beverages will be required to purchase them on location.
- * Ice will be EXCLUSIVELY supplied by Boshears Skyfest 2008.
Water is available at the base of the tower ONLY.
